Government of Nepal has negotiated a project loan and project grant with the Asian Development Bank (ADB) for financing the proposed Urban Resilience and Livability Improvement Project (URLIP) with the objective to improve livability and sustainability of urban service delivery in seven project municipalities – Pokhara MC, Janakpur SMC and Lumbini Sanskritik, Sainamaina, Devdaha, Tilottama, and Siddharthanagar of Western Urbanizing Corridor (WUC) – through municipal infrastructure improvement, regeneration of natural, cultural and heritage tourism assets, and institutional strengthening over a period of 6 years.

Janakpurdham PIU (the Client) on behalf of the EA now invites Expression of Interest (EOI) from reputed and interested engineering firms for short-listing in order to extend their service of **Supervision and Design Consultant (SDC)** which shall provide consulting services for design review, revision of design, detailed engineering design, preparation of safeguard documents, technical specification and bidding documents with supervision of works and contract management to support the URLIP.

The SDC comprising of national experts will be stationed in Janakpurdham. The SDC is a Time-based contract. The duration of consulting services is over a period of 45 months (3 months for design and 42 months for supervision; including defect notification period) which requires an estimated 269 national person months input of key personnel and 571 person months input of non-key personnel. This SDC assignment is estimated to be NRs **154,494,746.00** (Nepalese Rupees One Hundred Fifty-Four Million Four Hundred Ninety-Four Thousand Seven Hundred Forty-Six only) i.e. approximately USD 1,178,359.74 (including Provisional Sum and VAT).

EOI will be evaluated against a set of pre-approved criteria and Request for Proposals (RFP) will be sent to the Shorted-listed firms. Quality and Cost Based Selection (QCBS) method will be adopted using 80:20 weight for technical and financial score respectively for evaluating RFPs. EOI should be supported by details including name, registration details of firm(s), Joint Venture agreement in case of joint Venture, experience of projects of similar nature and size and complexity. EOIs should be supported by details including tax clearance up to fiscal year 2079/80 and VAT registration certificate.

The EOI documents should be submitted by 1st August, 2024 not later than 9:44 PM (GMT +5:45). The client reserves the right to accept or reject any and/or all EOIs without assigning any reason. Interested consultant firms should visit ADB's website for CSRN (<http://cms.adb.org>) about specific requirements and submit EOI following the instructions in the CSRN website (hard copy submission not applicable)
